**Part #3 – E-Resources (continued)**

Notes and Examples:

1. In Section C, you will need to keep adding the numbers for the holdings you have until you reach the total number required. For example, if the Trillium Library has one local database for local history that it created, one database for local social service agencies that it helps to update PLUS subscribes to two (2) E-resources (MasterFILE Premier and Canadian Reference Center) through Provincial Licensing, it would show 4 in line C3.2.0 (English column) as all are primarily English and you only want to count these once. The Trillium Public Library would also show the following in row C3.2.4 - show 2100 in the English column of line C3.2.4 (the total of 1579 periodical titles in MasterFILE Premier and 521 periodical titles in Canadian Reference Centre and 0 periodical titles for the two local databases); show 21 in number of individual French titles (4 in MasterFILE Premier and 17 in Canadian Reference Center) and 5 in 'other' column– as shown in the example below.

2. If you **subscribe to services such as Hoopla, Kanopy, Freegal, Freading, OverDrive Magazines, IndieFlix, Flipster, Naxos** the Ministry does not require that you record the number of individual titles in those collections. These services are recorded in “**C4.0- Streaming and Downloading services and subscriptions**”. If you have them, answer “Yes” in C4.1 “Does your library offer Downloading and Streaming Services” and then in C4.2, indicate the number of services, with **each** separate service counting as “one”.
